**CEO Update** - By Christine Fox, President-CEO

Another year has flown by. Our team just completed the 2021 yearend financial statements and is preparing for

the financial audit. Surprisingly 2021 surpassed the incredible year we had in 2020. Here are just a few of the highlights:

- Itasca-Mantrap experienced a thirteen percent growth in revenue across all but one of our rate classes. Further, 2021 brought an additional 222 new services, which was 26 more than 2020. If you recall, our 2020 was more than double 2019 installations.
- Due to this incredible growth, Itasca-Mantrap purchased 28.7 million more kWh than in 2020.
- Our average cost of power per kWh increased by 4 percent, primarily due to higher market costs to our power supplier, Great River Energy (GRE). Higher market costs are passed along to Itasca-Mantrap in the form of a Power Cost Adjustment (PCA) charge. Itasca-Mantrap incurred a PCA charge in all but 1 month in 2021. Our Board and Staff elected not to pass those charges on to our members – and yet we were able to finish the year ahead of budget.
- Our operating costs (excluding power) were down \$483,000 from 2020 due to several factors, including:

- o Fewer costs associated with Team Member absence due to COVID.
- o Efficiencies gained by bringing a portion of our right-of-way maintenance program inhouse.
- o Fewer outages and therefore fewer costs for restoration of outages.
- o Fewer costs associated with workers compensation insurance due to our excellent safety record.
- o Efficiencies gained by team member suggestions and process improvements.

In fact, the only areas with increased costs over 2020 were in education/ training and member service. These are costs that we have purposely increased as an investment in our future.

- Depreciation expenses were over budget and greater than what was expensed last year. Since we are ahead of schedule on our Advanced Grid Infrastructure (AGI) project, we changed our accounting estimate of the useful life of our old meters and metering system. This resulted in an additional expense of \$1.2 million in 2021 and means we won't have to take a loss in the future.
- We re-priced some of our loans at a much lower interest rate and therefore saved money in interest expense.
- We received a patronage allocation from GRE of slightly more than \$1 million. This is about \$600,000 more

than in 2020.

• With GRE's allocation, we ended the year with a net margin of \$2.2 million.

One of the many benefits of being a cooperative member is that you share in these margins. After the books have been audited, these net margins will be allocated to you based on your usage. This allocation is called patronage or capital credits. In the cooperative model, the capital credits are considered equity. Like a for-profit corporation, the equity is held to allow us to conduct business. Dissimilarly, the capital credits are returned to you in the form of a check sometime in the future when the Board elects to retire them.

Speaking of which, your Itasca-Mantrap Board elected to retire capital credits during their January Board meeting – GRE capital credits through 1992 totaling \$292,365.45 and Itasca-Mantrap capital credits through 2004 totaling \$770,102.66 for a total over \$1 million. If you were a member during 1992 and/or 2004, you should have received a check from us.

I am looking forward to another remarkable year in 2022.

# affordable ways to LOWER HEATING COSTS and keep you warm

#### **CUT HEATING COSTS THIS WINTER**

- Cut up to a fifth of your bill by sealing exterior wall leaks and drafts
- If there are leaks or holes in your ducts, use sealant or metal tape. Air leaks in ducts can account for about 20-30 percent of wasted heat.
- Lower the temperature while sleeping or away. A programmable thermostat can save up to 15 percent.
- Water heaters account for nearly a fifth of heating bills. Set yours to no more than 120 degrees.
- Use a space heater to help warm a room and keep the home setting lower. A one degree reduction can save 3 percent on the bill.
- Open drapes on sunny days and change the furnace filter monthly.



## ICE ON POWER LINES IS A WEIGHTY SUBJECT

When it comes to getting electricity across power lines and into homes, ice can be a force to be reckoned with.



#### **ICE ON DISTRIBUTION LINES**

Ice can quickly lead to broken power poles and other pole equipment. Ice can also make falling tree branches 30x heavier and much more likely to break power lines.

#### ON A 300-FOOT SPAN OF 1-INCH-THICK POWER LINES

- 1/2 inch of ice adds 281 pounds of weight
- 1 inch of ice adds 749 pounds of weight
- 2 inches of ice adds 2,248 pounds of weight

#### WHEN ICE MELTS

Melting ice can cause power outages. If ice on the bottom (neutral) line melts before the lines above, it can cause the lines to touch.

## OTHER ICE FACTS

- Damage can begin when ice exceeds 1/4 of an inch
- 1/2 inch of ice can cause a line to sag up to 12 inches
- Pressure can also be caused by a broken tree limb
- Both ice and melting ice can cause power outages

### More than \$1 million in Capital Credits Paid to Members

There are many benefits that come with co-op membership, but perhaps one of the best benefits is capital credits.

What are capital credits? As a Member of Itasca-Mantrap, you invest in the efficient operation of your Cooperative. Unlike an investorowned utility, Itasca-Mantrap doesn't pay dividends or other amounts to shareholders who don't purchase electricity from us. Therefore, any excess revenue - or margins - is allocated back to the Members in the form of capital credits.

At the end of each year, Itasca-Mantrap calculates its operating margin, which is the amount by which operating income exceeded operating expenses during the year.

Itasca-Mantrap then allocates the excess margins as capital credits to each Member based on the amount of electricity purchased throughout the year. When the board of directors determines it is financially feasible, capital credits are retired - or paid back to Members - in the form of a check.

In the interim, Itasca-Mantrap uses the allocated, but unretired, capital credits to improve and expand the electric system and meet other capital needs. This reduces the need to borrow money and helps provide reliable electric service.

Checks were issued in February totaling more than \$1 million. The capital credits include Itasca-Mantrap capital credits through 2004 and Great River Energy credits through 1992.

Capital credits paid to members, previous members and estates, paired with the more than \$1 million distributed this February nets more than \$1.4 million paid to members in 2021.

To help ensure you receive your capital credits, please update your address after you move.

HOW DO CAPITAL CREDITS WORK?



Itasca-Mantrap tracks how much electricity you purchase throughout the year.

At the end of the year, Itasca-Mantrap completes financial matters and determines whether there are excess revenues, called margins.



Itasca-Mantrap allocates margins to Members as capital credits based upon their use of electricity during that year.

When the co-op's financial condition permits, your board of directors decides to retire, or pay, the capital credits.
