CEO UPDATE

As spring arrives and the ground thaws, our operations team is gearing up for another busy construction season. This is the time of year when we're out in force—replacing aging lines and equipment, building new services, and upgrading our system. This work is a key part of our commitment to providing safe, efficient, and reliable electricity to power our members' homes and businesses for years to come.

Planning these projects often begins years in advance with detailed engineering analysis. Our engineering team uses advanced modeling software to evaluate system loading, voltage levels, and anticipated growth across our service territory. This data helps us identify areas where the infrastructure is under strain or where increased demand is expected. We also review outage history and reliability metrics to locate parts of the grid that would benefit most from upgrades. This strategic, data-driven approach allows us to prioritize projects based on need, ensuring we enhance system performance and continue delivering reliable service to our members.

Of course, none of this work would be possible without a strong focus on safety. The safety of our crews and the communities we serve is always our top priority. You may see our crews working any time of the day or night—and in all types of weather—responding to outages, completing planned upgrades, or preparing for future development. We ask that you please drive carefully when passing work zones and give our crews the space they need to work safely.

If you have your own construction plans this summer-whether it's building a deck, putting up a fence, or planting trees—we urge you to plan ahead and stay safe. Be sure to contact Gopher State One Call by dialing 811 at least three working days before you dig. This free service will locate public underground utilities like electric, gas, and water lines up to the meter. However, it does not mark any private underground lines that may have been installed by the property owner, such as power to outbuildings, yard lights, wells, or irrigation systems. If you suspect there may be private utilities on your property, it's your responsibility to have them located. Consulting with your electrician or a private locating service is the best way to do so. Taking these steps can help you avoid a dangerous and costly accident.

We appreciate your cooperation and support as we work to keep our electric system strong and reliable. Here's to a safe and productive construction season—for all of us.



UPCOMING 2025 RATE ADJUSTMENTS FOR COMMERCIAL AND LARGE POWER ACCOUNTS:

WHAT THE RATE CHANGES MEAN

As your electric cooperative, we are committed to providing you with safe, reliable and affordable electricity. We have successfully held off a rate increase since 2018. We made it through COVID-19 and the resulting supply chain and inflationary issues. However, due to years of rising costs, we can no longer continue to absorb these increases and now find we must adjust our rates. Effective with the July 2025 billing, our small commercial, large commercial and large power accounts will see a rate increase. A residential rate increase is expected in 2026.

Why is this necessary?

Wholesale power costs, which make up approximately 69% of our total operating expenses, continue to rise. Our wholesale power supplier, Great River Energy (GRE), has announced an 8.5% increase. This increase reflects the need for critical investments in grid infrastructure, which will strengthen our system's resilience, expand future capacity, and support the transition to renewable energy sources, a mandate from the state.

When will this increase go into effect?

Small commercial, large commercial and large power accounts will see this rate adjustment with the July 2025 billing, to be sent out in August.

Investments in a Resilient and Sustainable Energy System

The investments we are making now will result in a more resilient, efficient, and sustainable energy system in the future. These efforts will help strengthen our grid, protect against outages, and better prepare us for the challenges posed by climate change and increased energy demand. They are also crucial for supporting the state's mandate to transition toward renewable energy sources, which requires significant upgrades to our infrastructure.

Residential rate increase coming in 2026

While this rate adjustment will apply to commercial and large power accounts in 2025, we want to let our residential members know that a rate increase is planned for 2026. This increase will help us continue to manage rising wholesale power costs and maintain our commitment to a resilient, sustainable energy system. We will provide more details about the residential rate adjustment in future editions of NewsLine.

Looking ahead

We understand that any rate increase can be challenging, and we want to assure our members that these decisions are being made with careful consideration. We are committed to managing costs efficiently while ensuring we have the infrastructure and resources to meet your energy needs, both now and in the future.

Thank you for your continued support and understanding as we work to build a stronger, more adaptable energy system for all our members. We remain dedicated to providing you with safe, affordable electricity and will continue to keep you informed as we make these important investments.


Youth Tour Delegate Selected

Itasca-Mantrap's summer electric rates will go into effect in June. The general service rate for June, July and August is 12 cents per kilowatt-hour (kWh), compared to 10 cents per kWh from September through May. The Basic Charge for residential services is \$38 per month throughout the year.
