### Important:

- Rebate amounts: Storage space heating rebate: **\$100** per kilowatt (kW) of installed electric storage heat.
- Limit one rebate per application.
- The space heat must be installed within Itasca-Mantrap's service territory.
- Incomplete forms will not be processed.
- The space heat must be separately metered and controlled on Itasca-Mantrap's off-peak storage program.
- Include a copy of the original dated sales receipt.
- Complete all member information including your account number and sign this form.
- Rebate will be processed after form is complete and total installed kW is confirmed by an Itasca-Mantrap technician.
- Submit completed rebate form and a copy of the original sales receipt within 90 days of purchase date to: Itasca-Mantrap, PO Box 192, Park Rapids, MN 56470.
