### Important:

- Rebate amounts: Dual Fuel heating rebate: **\$25** per kilowatt (kW).
- Limit one rebate per application.
- The system must be installed within Itasca-Mantrap's service territory.
- Incomplete forms will not be processed.
- The dual fuel heat must be separately metered and controlled on Itasca-Mantrap's dual fuel program.
- Include a copy of the original dated sales receipt.
- Complete all member information including your account number and sign this form.
- Rebate will be processed after form is complete and total installed kW is confirmed by an Itasca-Mantrap technician.
- Submit completed rebate form and a copy of the original sales receipt within 90 days of purchase date to:
