PAYMENT PLAN TERMS AND CONDITIONS**

Member agrees to the following regarding the payment plan for the Participation Fee (these Terms and Conditions form a part of the Agreement and its Exhibit 1):

1. Member promises to pay to Itasca-Mantrap the Participation Fee in the indicated monthly installment amounts.
2. No interest is payable on the Participation Fee, but Member will be charged a late payment fee of 1.5% of the unpaid amount if not paid when due, which fee is assessed until payment is received.
3. The Participation Fee may be paid off early without penalty.
4. The Member authorizes the Participation Fee installment charges to be included on Member's monthly invoice for the Account until paid in full. If for any reason invoice billing becomes unavailable, Member will pay the installment charges as billed by Itasca-Mantrap through other means.
5. The charge will be due and payable in accordance with the terms of the electric service invoice. All payments by Member on an invoice will be first applied to charges for electric service then as payment for amounts due under the Payment Plan.
6. In the event any installment payment is not paid within fifteen (15) days of its due date, the entire remaining balance of the Participation Fee shall accelerate and immediately become due and payable without further notice. In any such event(s), Member agrees to pay the remaining balance of the Participation Fee in full on the written demand of Itasca-Mantrap. If Member's electric service is disconnected, Member shall continue to make the installment payments due, unless Member's participation in the Program is terminated, in which event the entire remaining balance of the Participation Fee is accelerated, and will be due and payable in full without further notice. Further, in the event Member terminates electric service at the Service Address, the Participation Fee is accelerated and will be due and payable in full without further notice.
7. Member's election to utilize the Payment Plan constitutes a promise to pay the Participation Fee in accordance with the above terms and conditions, and the persons signing as Member, if more than one, shall be jointly and severally liable for payment of the Participation Fee.
