CEO Update - By Christine Fox, President-CEO

The reliability of our electric grid has been on many people's minds lately...and for good reason.
Our recent (I am writing this at the beginning

of March) weather pattern has put the grid to the test. And many systems failed that test. The Southwest Power Pool, commonly referred to as the "SPP," initiated the first rolling blackouts in their history. Our neighbors as close as Moorhead and much of North Dakota were affected by them. As we have all seen in the media, ERCOT (Texas Power Grid) failed miserably, initiating their first rolling blackouts in decades. While there is much speculation of what happened and who is to blame, I want to focus on the fact that we, at Itasca-Mantrap, had nothing to worry about.

Our wholesale supplier, Great River Energy (GRE) is no stranger to cold weather. Its system is designed to provide reliable electricity in extreme weather conditions. GRE's facilities – coal, gas, fuel oil and wind – performed as planned. These facilities were under a maximum generation directive from our Midwest Independent System Operator (MISO) and all facilities performed well.

MISO North never even considered rolling blackouts. Although the market price to purchase electricity went sky high, GRE was generating and selling into the market as much as we were buying from the market. Additionally, GRE stocks fuel oil and was able to mitigate the absurdly priced natural gas by burning their reserved fuel oil at several of their peaking facilities. We, at Itasca-Mantrap did our part by controlling load at optimal times to help reduce our cost. Thank you to all our members who are on our load-control programs!!!

So, what does this mean for a "renewable energy future"? As the independent system operator, MISO takes responsibility for ensuring the region's grid has sufficient energy, capacity, and transmission. As a member of MISO, GRE is required to have the capacity to meet peak demands. This is not optional. As the electric system evolves, so will MISO's reliability requirements. MISO has been a leader in establishing and monitoring requirements for utilities that ensure the region has reliable energy. MISO continuously studies the needs of the regional grid, and GRE is a key part of those studies.

At this point, GRE has planned to close Coal Creek Station and will not have any coal-powered generation facilities in the future. They, and we at Itasca-Mantrap,

are doing everything in our power to do our part in slowing/preventing climate change. But we are still reliant on fossil fuels to run peaking plants when severe conditions occur. The good news is that these peaking plants are only called upon during these severe conditions. This latest weather event only emphasizes the fact that although we can reduce our carbon footprint substantially, we still do not have the technology to be completely free of fossil fuels. We have not yet invented the battery (or alternative) that will last for ten days. Although, here at Itasca-Mantrap, our energy future relies much less on fossil fuels. The latest prediction is 94% carbon-free, not including market purchases, by 2025. While this is great, we do not have the technology to get to 100% yet. Hopefully by the time we get to 94%, we will have the technology to make that final step without risking reliability. The last thing any of us wants is to be in a situation like the one Texans just endured.

Please know that GRE is committed to Itasca-Mantrap and our members and we are all committed to reliable, affordable, and clean energy. The future is bright!



5 STEPS FOR SAFE DIGGING

Working on an outdoor project? Always call 8-1-1 first, because you never know what's below. Here are five easy steps for safe digging:

1. NOTIFY

Call 8-1-1 or make a request online two to three days before you start.



2. WAIT

Wait two to three days for a response to your request. Affected utilities will send a locator to mark any underground utility lines.



3. CONFIRM

Confirm that all affected utilities have responded by comparing the markers to the list of utilities the 8-1-1 call center notified.



4. RESPECT

Respect the markers provided by the affected utilities. They are your guide for the duration of your project.



5. DIG CAREFULLY

If you can't avoid digging near the markers (within 18-24 inches on all sides, depending on state laws), consider moving your project.
