Itasca-Mantrap Co-op. Electrical Ass'n. is obligated to interconnect with and purchase electricity from cogenerators and small power producers who satisfy the conditions of a qualifying facility. Itasca-Mantrap will provide information to all interested Members, upon request, regarding rates and interconnection requirements.

An application for interconnection is required for a qualifying facility to interconnect and operate in parallel with the Cooperative's distribution system and is subject to approval by the Cooperative. Any disputes over interconnection, sales and purchases are subject to resolution by the Itasca-Mantrap Co-op. Electrical Ass'n. Board. # Tips for a Safe Harvest

Harvest season brings hard work and can be exhausting, but rushing the job to save time can be extremely dangerous (even deadly!) when working near overhead power lines. We urge farm operators and workers to keep the following safety tips in mind:

Use care when operating large machinery near power lines.

Inspect the height of equipment to determine clearance.



Always keep equipment at least 10 feet away (in all directions) from power lines.



Remember to lower extensions when moving loads.



If a power line is sagging or looks to be dangerously low, please call us immediately.

#### **Military Assistance**

#### **Utility payment arrangements**

When a household member has been ordered into active duty, for deployment, or for a change of duty station, some members may find it hard to pay their utility bills. Minnesota law protects these military personnel from shut-off if they cannot pay their utility bills in full.

#### How to apply

Contact Itasca-Mantrap to obtain an application and make a payment plan, which you must keep to qualify for protection.

#### **Payment plans**

- If your household income is below the state median household income, pay ten percent of your household's gross monthly income toward your electric bill; or
- If you receive energy assistance, pay ten percent of your household's gross monthly income toward your electric bill; or
- If your household income is above the state median household income, make and keep a payment plan.



### Trees, power lines, and outages

Affordability and reliability consistently rank as two of the most important aspects of electric service for electric cooperative member-owners. Itasca-Mantrap knows that exceptional reliability doesn't happen by chance. It takes diligence in maintaining power lines and equipment; continuously improving where necessary and anticipating our members' increasing needs for electric service.

In every season, there is one common threat to reliability – trees. Like you, we value trees being part of Minnesota's landscape. Not only do they provide beautiful visual appeal to yards, streets, and parks, they also provide relief from the summer sun, barriers to noise, environmental benefits and even food and shelter. While trees are valuable to us all, they are also one of the leading causes of power outages.

When branches and limbs break during storms, they frequently land in roadways or bring the power lines down, posing a safety risk to Itasca-Mantrap's employees, our members and the public. Because our distribution system connects thousands of people across our service territory, one tree encountering a power line can have a domino effect. To mitigate this issue, Itasca-Mantrap works hard to make sure trees have less impact on the overall safety and reliability of the infrastructure used to deliver electric service 24/7, 365 days a year.

Throughout the year, you will likely see our crews inspecting and trimming trees and other vegetation. Both federal and state policies require that vegetation must be cleared from power lines as a safety measure for member-owners and our employees. These groups have strict guidelines, including prohibiting trees from being planted or growing within certain distances from power lines in or near the rights of way. Utilities face substantial penalties if we don't comply. Our vegetation management program is designed to identify and fix problems before they become more costly or result in a prolonged loss of power. Our approach is similar to how you have your home's air conditioner tuned up before summer or get regular oil changes in your vehicle. Regular maintenance improves performance and longevity of essential assets.

Our crews are trained in approved trimming methods. This expertise allows us to remove the portion of the tree that could pose a safety and reliability threat while maintaining as much as possible of the tree's visual appeal. We take great care in managing these natural resources to preserve their longevity and beauty for many years to come.

## **Electrical Inspections**

Generally, Minnesota requires all electrical work to be performed by licensed, bonded and insured electrical contractors and their employees. Homeowners, with strict limitations, are exempt from licensing, but not from inspection. A separate request for electrical inspection form with the required fees must be submitted to the Department of Labor and Industry at or before the commencement of any electrical installation. If you have had electrical circuits added, extended or altered you should have also had a visit from your local electrical inspector.
